Old Business:

 A motion was made seconded and passed to adopt an amendment to the by-laws to add Section 5A under Article VI to create an Executive Committee.

New Business:

- Executive Committee Report

Geoff Gunnell declined to resign.
 - A vote was taken with 7 in favor and 1 opposed to accept the resignation request as presented by the Executive Committee.
- Request for Speaker at Home Party
 - O An individual on Lambeth has contacted Neighborhood Watch requesting a training session at a social event at his house. After discussion, it was concluded that Dan and Susan may attend the event to discuss properly arranging a training session.
- Crime Reports vs Raids on Line
 - O Concerns were expressed that the website's link still takes people to Crime Reports instead of Raids on Line. Tim verified that the link take the user to the proper website.

- October 11 Training
 - o Mary will check her calendar and Joe is open for the October 1 training session at Grace Church.
- Old Manual Link on Website
 - o The website link to the Neighborhood Watch manual is incorrect and needs to be updated.
